Special Permit Conditions:

PERMIT CONDITIONS

This permit shall apply only to:

- Irrigation of new sod or seeded grass lawns or landscaping within the first 21 consecutive days of planting.
- Irrigation of new landscape plantings should consist of a group of plantings. Single plantings should be watered with a handheld hose, watering can or soaker hose.
- Irrigation shall not be conducted between 10:00 AM and 6:00 PM.
- Exemptions will not be granted June 17th through September 13th, unless the work is required as part of new construction.
- Permits are not valid during Emergency Stages 3 and Stage 4.
- The permit ***MUST*** be displayed at the property where it is visible from the street.
