

**VILLAGE OF RIDGEWOOD
ORDINANCE NO. 3940**

**AN ORDINANCE TO AMEND CHAPTER 269 OF
THE CODE OF THE VILLAGE OF RIDGEWOOD, WATER,
AT ARTICLE IV: IRRIGATION SCHEDULE AND WATER EMERGENCIES**

BE IT ORDAINED by the Village Council of the Village of Ridgewood:

Section 1: Chapter 269-44 thru 269-48, of the Code of the Village of Ridgewood is hereby amended as follows:

DELETE 269-44 Definitions

SMART CONTROLLER

A weather-based irrigation controller or soil moisture based irrigation controller meeting criteria specified and labeled as being compliant under the United States Environmental Protection Agency Water Sense Program, and meeting the guidelines prescribed by Ridgewood Water.

ADD 269-44 Definitions

SMART CONTROLLER

A weather-based irrigation controller or soil moisture based irrigation controller meeting criteria specified and labeled as being compliant under the United States Environmental Protection Agency Water Sense Program, meeting the guidelines prescribed by Ridgewood Water and approved by permit from Ridgewood Water.

DELETE 269-45 Declaration of emergency

The Village Manager is authorized to enforce the provisions of this article and, in his discretion, to determine and declare the existence and extent of an emergency with respect to the water supply of the Village of Ridgewood. The determination of the Village Manager shall apply to all communities served by the Department of Water Supply of the Village of Ridgewood, and notification of the emergency shall be promulgated to all such communities in the most reasonably expeditious manner. Interim emergency regulations may be adopted without notice by the Village Manager of the Village of Ridgewood and shall apply to all communities serviced by the Department of Water Supply of the Village of Ridgewood and shall be promulgated in the most reasonably expeditious manner to all the communities.

ADD 269-45 Declaration of emergency

The Village Manager is authorized to enforce the provisions of this article and, in his/her discretion in consultation with the Director of Ridgewood Water, to determine and declare the existence and extent of an emergency with respect to the water supply of the Village of Ridgewood. The determination of the Village Manager shall apply to all communities served by the Department of Water Supply of the Village of Ridgewood, and notification of the emergency shall be promulgated to all such communities in the most reasonably expeditious manner. Interim emergency regulations

may be adopted without notice by the Village Manager of the Village of Ridgewood and shall apply to all communities serviced by the Department of Water Supply of the Village of Ridgewood and shall be promulgated in the most reasonably expeditious manner to all the communities.

DELETE 269-48.D (2)

Irrigation of lawns or plantings with smart controllers,

ADD 269-48.D (2)

Irrigation of lawns or plantings with smart controllers, approved by permit from Ridgewood Water, and limited to the irrigation hours specified in Section E of this Chapter

DELETE 269-48.E

Irrigation shall not be conducted between 10:00 a.m. and 6:00 p.m. on any day. Irrigation using automatic systems may only be used between 3:00 a.m. and 7:00 a.m. on the permissible day.

ADD 269-48.E

Irrigation shall not be conducted between 10:00 a.m. and 6:00 p.m. on any day. Irrigation using automatic systems, including Smart Controllers, may only be used between 3:00 a.m. and 7:00 a.m.

Section 2: Except as herein amended and supplemented, Chapter 269-Article IV, of The Code of the Village of Ridgewood remains in full force and effect.

Section 3: This ordinance shall take effect immediately upon passage and publication as required by law.


