Continue to Conserve Water

As we work to meet new PFAS standards, we are delivering water via wells that contain the least amount of PFAS. When our customers conserve water, it enables us to continue to draw on wells with the lowest PFAS levels and helps us manage the water supply during periods of low rain. In addition to following the twice-a-week watering schedule, you can conserve water by turning off the faucet while shaving or brushing your teeth, taking shorter showers, operating the dishwasher only when full and using the appropriate water level or load size selection on your washing machine.

Be Water Wise!

REDUCE WATERING TIME BY 20%. If you usually run your sprinklers for 20 minutes, cut back to 16 minutes. If your lawn still looks good, cut back by an additional 4 minutes. It makes a big difference!

SIGN UP FOR WATERSMART. WaterSmart is a free service that shows you how much water you are using and helps create a plan on how to use 20% less. <u>Sign up here.</u>

FOLLOW THE TWO-DAY WATERING SCHEDULE. The schedule below is MANDATORY and critical to avoiding further water restrictions. *Reminder: No residential watering on Monday, Thursday or Friday.*

Did You Know?

Overwatering can lead to a lawn with a very shallow root system...and shallowly rooted grass is easily stressed and susceptible to disease and damage from insects. These conditions also make your lawn less likely to thrive during a drought or dry spell - another reason to water wisely.

The Environmental Protection Agency (EPA) recently issued the first national regulation limiting the presence of the most common types of "forever chemicals." Water suppliers in the United States have until 2029 to reduce the levels of PFOA and PFOS to 4 parts per trillion.

Ridgewood Water is on target to reach *nondetectable* levels of all regulated PFAS compounds by the end of 2026 - *three years ahead of the EPA deadline*.

It should certainly be noted that we are working faster than the majority of communities in the country to eliminate PFAS.

Report Hydrant Robbery

Ridgewood Water staff and local firefighters should be the only people operating hydrants, unless a permit has been issued by Ridgewood Water. So if you see a "hydrant robbery" taking place, please report it to our customer service department at cswater@ridgewoodnj.net or 201-670-5520. Unauthorized operation of a hydrant can result in discolored water or even cross-contamination of the Ridgewood Water distribution system.

Update: Lead Service Line Replacement

- The Lead Service Line Replacement Program is in the Opt-in/Opt-out period through December 1, 2024. We encourage all Ridgewood Water customers who want to have their lead or galvanized service line replaced through the program to OPT IN. When firm prices are determined later this year, you will have an additional 30 days to make a final decision.
- To date, we have received more than 500 responses and inquiries, with nearly 300 customers choosing Option 1 (Ridgewood Water Contractor) and more than 100 choosing Option 2 (Private Contractor).

- If you don't know whether your service line is made of lead, use the <u>Service Line Look-Up Tool</u> to find out. If the material is "unknown," contact Ridgewood Water at cswater@ridgewoodnj.net or 201-670-5520 to schedule an inspection. Or you can ask your plumber to verify the material before scheduling your replacement.

How Water Meters are 'Read'

For billing purposes, staff members remotely "read" water meters from their vehicles once each quarter. (They drive down every street in town on the day of the reading!) The meter reading dates below are approximate. Customers will receive their bill seven to 14 days after the read date. For more information about your water usage, sign up for <u>WaterSmart</u>.

Road Work Ahead

A raw water main is being installed on **Doremus Avenue** and **Ackerman Avenue** - along Doremus Road from the Glen Rock-Ridgewood border (just south of Orchard Place) to Ackerman Avenue/Bellair Road. Traffic detours will be in effect for the duration of the work. The raw water main will allow water from the Glen Rock well to flow to the West End PFAS Treatment Facility, which is currently under contract to be constructed. 
Selling Your Home?

Be sure to call Ridgewood Water (201-670-5520) to schedule a final reading of your water meter.

- Information required for the reading: location address, name and phone number of current owner, new owner name and at least one form of contact for new owner, closing date, and attorney name and email.
- The requested meter reading date should be three to five days before closing.
- Who will be making the final payment? Seller? Attorney? Title company?
- Typically, no one needs to be home to read the meter.
- The water does NOT get turned off at the curb due to a transfer of ownership.

Be Water Wise!

Water usage *triples* during the summer months, which is why Ridgewood Water's two-day watering schedule became the permanent baseline in Glen Rock, Midland Park, Ridgewood and Wyckoff. Complying with two-day watering ensures that sufficient water will be in reserve for firefighting and other emergencies. Ensuring Safety and Trust

Ridgewood Water ensures the safety and trust of the clients we serve by requiring all employees to carry photo ID cards and drive vehicles that are clearly marked with our logo. This practice allows residents to easily identify legitimate Ridgewood Water personnel, whether they are performing routine maintenance, responding to service calls or working on infrastructure projects. Have any doubts? Ask to see the employee's ID!

Construction Update

At the September 4th Village of Ridgewood Council Meeting, Rich Calbi, director of Ridgewood Water, presented an update on the construction of the PFAS Treatment Facilities. Bottom line: Two facilities are currently active, five are under construction, and the entire system is on schedule to be treated by the end of 2026.

Capital Improvement Update

Last week, the Ridgewood Village Council approved the contract for the construction of the **Wortendyke PFAS Treatment Facility** - the third of the four largest facilities in the system (a.k.a. "The Big 4") to go under contract. Next step: approval by the New Jersey Department of Environmental Protection, after which a notice to proceed will be issued. The anticipated completion date for the Wortendyke PFAS Treatment Facility is October 2026.

Fall Sprinkler Maintenance

Fall is typically the end of the gardening season, making it the ideal time for sprinkler system maintenance. Performing maintenance in the fall gives you sufficient time to schedule any necessary repairs before the winter freeze or the busy spring season. Besides your sprinkler system, be sure to check outdoor faucets and pipes for leaks.
